**General Bid Notes**

1. Award will be made on the total sum of Contract Line Items 0001AA through 0001AL. For CLINs 0001AC through 0001AL and CLIN 0002AA enter unit prices and extended totals in spaces provided. If there is a difference between a unit price and the extended total, the unit price will be held to be the intended bid and the total recomputed accordingly. If an Offeror provides a total but fails to enter a unit price, the total divided by the specified quantity will be held to be the intended unit price.

2. The Government reserves the unilateral right to award CLIN 0002 to the Contractor at the proposed price within 120 calendar days after the contract award. A firm fixed proposed price is required for CLIN 0001 and CLIN 0002. No provision is made for economic price adjustment. If the Option is exercised, award of CLIN 0002 extends the contract completion date by 45 calendar days upon award of the CLIN.

3. Evaluation of Options. Except when it is determined in accordance with FAR 17.206 (b) not to be in the Government's best interest, the Government will evaluate offers for award purposes by adding the price for the Option(s) to the total price for CLIN 0001. In accordance with FAR 52.217-5, evaluation of options will not obligate the Government to exercise the Option(s).

4. The Government may reject an offer as nonresponsive if it is materially unbalanced as to prices for the basic requirement and the option quantities. An offer is unbalanced when it is based on prices significantly less than cost for some work and prices which are significantly overstated for other work.

5. If CLIN 0002 is exercised, additional bonding and consent of surety is required. Consequently, the Performance Bond must reflect 100 percent of the aggregate amount of all Items. f. The unit and lump sum prices for various items in the schedules above shall be deemed to include all costs required for the specified work, complete in accordance with the drawings and specifications, including all materials, labor, equipment, tools, supervision and related items.

6. The quantities shown in the Schedule of Bid Items (and on the drawings) are ESTIMATES only. Should the actual quantities of any of the items required to complete the work vary from the estimate, the unit price will be adjusted in accordance with the CONTRACT CLAUSE entitled "Variation in Estimated Quantities".
