AMC 3. Acquire, for the second or subsequent time, directly from the actual manufacturer.

AMSC B. This part must be acquired from a manufacturing source(s) specified on a source control or selected item drawing as defined by the current version of DoD-STD-100. Suitable technical data, Government data rights, or manufacturing knowledge are not available to permit acquisition from other sources, nor qualification testing of another part, nor use of a second source part in the intended application. Data review discloses that required data or data rights are not in Government possession and cannot be economically obtained.

This acquisition will be negotiated with: Pacific Scientific, CA (06331)

This item is aviation critical. The minimum need can only be provided by Pacific Scientific, CA because they are the only approved source that has demonstrated the unique design capability, manufacturing knowledge, or technical data required to manufacture this item. These parts are critical safety of flight components and require engineering source approval by the design control activity in order to maintain the integrity of the part and escape system. Therefore, this acquisition will be for continued production of highly specialized equipment. Any interested parties will need to coordinate with this office and fund their own efforts to become qualified to produce this item. If the buyer discovers information to the contrary, it will be furnished to the PR initiator for appropriate action. This item is a Critical Safety Item.

6. DESCRIPTION OF EFFORTS MADE TO SOLICIT OFFERS FROM AS MANY OFFERORS AS PRACTICABLE: The proposed contract action was synopsised and included a Sources Sought Notice on the FedBizOpps website for government-wide point of entry on

Jan 29, 2016

and as a result:

Market Research was conducted in accordance with FAR part 10. The results of the Market Research conducted (or the reason market research was not conducted) is as follows:

A technical review was completed by reviewing the results of previous market research for identical items to determine and identify all known sources as of September 15, 2015. The results of this review have determined that no new sources have expressed an interest in manufacturing this item. A Sources Sought Notice was posted for Solicitation N00104-16-R-K050 from January 29, 2016 to February 15, 2016. No new sources were interested.

Due to the critical application of this item, alternate source(s) must be approved in accordance with the design control activities' procedures and requirements which have been established by NSWC, IH systems engineer prior to contract award. The Government does not have the data rights or the funding available to support second source qualification efforts. Offerors must possess access to all appropriate data.

7. DETERMINATION OF FAIR AND REASONABLE COST: The contracting officer determines that the anticipated cost to the Government of the supplies covered by this J&A will be fair and reasonable.

8. ACTIONS TO REMOVE BARRIERS TO FUTURE COMPETITION:

Future requirements for this material will be evaluated to see if the material can be procured on a competitive basis. This item will be reviewed under the NSWC, IH EODTD Aviation Critical Safety Items program, as implemented by DFARS PGI 209.270-4. If a vendor is interested in manufacturing this item, they will be referred to NSWC, IH for further instructions.
