**4. IDENTIFICATION OF STATUTORY AUTHORITY:** This J&A is based upon the authority of 10 USC 2304(c)(1), as implemented by Federal Acquisition Regulation 6.302.1

**5. DEMONSTRATION OF CONTRACTORS UNIQUE QUALIFICATIONS:** The current Acquisition Method Code (AMC/AMSC) is 3B. This acquisition will be negotiated with

BREEZE-EASTERN CORP.

Only the above will be solicited because the articles to be acquired are highly specialized parts, designed and manufactured by a non-Government activity and the technical data required for acquisition by other than the above is not available.

6. **FEDERAL BUSINESS OPPORTUNITIES/POTENTIAL SOURCES:** The proposed contract was/will be synopsised in the FedBizOpps website for government wide point of entry.
7. **DETERMINATION OF FAIR AND REASONABLE COST:** The contracting officer determines that the anticipated cost to the Government will be fair and reasonable. 11. **ACTIONS TO REMOVE BARRIERS TO COMPETITION:** The Naval Inventory Control Point Source Development Department has completed a full screen review on the Aircraft Drum Winch. The AMC/AMSC is "3B" source controlled listing Breeze Eastern (08484) as the only approved source of supply. No other sources have expressed an interest in manufacturing the subject item to the Source Development Department. The subject item is source controlled and requires pre-qualification on all new sources. The subject item is considered critical to safety of flight; therefore, additional sources must obtain engineering source approval prior to contract award. The NAVICP will continue to encourage manufacturers with the expertise to manufacture the subject item to submit a complete technical data package for review and source approval by the NAVICP, NADEP and NAVAIR. Future requirements will be advertised in the FedBizOpps website ([www.fedbizopps.gov](http://www.fedbizopps.gov)) and the NAVICP Buy Requirements Listing in order to encourage potential suppliers to submit Source Approval Requests.
