11. **ACTIONS TO REMOVE BARRIERS TO COMPETITION:** The AMC/AMSC is (3C) with (00KN7) CAPITAL LOGISTIC SERVICES as an authorized distributor for (73949) GUARDIAN ELECTRIC MFG CO the only approved source of supply. Available data has not been found adequate to support competitive acquisition. The subject item is considered critical to safety of flight: therefore, additional sources must obtain engineering source approval prior to contract award. NAVICP will continue to encourage manufacturers with the expertise to manufacture the subject item to submit a complete technical data package for review and source approval by the appropriate engineering source approval authority, namely, NAVICP, NADEP or NAVAIR.
