Only the above will be solicited because the articles to be acquired are highly specialized parts, designed and manufactured by a non-Government activity and the technical data required for acquisition by other than the above is not available.

6. **FEDERAL BUSINESS OPPORTUNITIES/POTENTIAL SOURCES:** The proposed contract was/will be synopsised in the FedBizOpps website for government wide point of entry.
7. **DETERMINATION OF FAIR AND REASONABLE COST:** The contracting officer determines that the anticipated cost to the Government will be fair and reasonable. 11. **ACTIONS TO REMOVE BARRIERS TO COMPETITION:** The AMC/AMSC is (2C) with THE MONADNOCK COMPANY (60119) PN 121500-4 AND ALCOA GLOBAL FASTENERS INC (29372) PN CA21285-4 as the only approved sources of supply. No other sources have expressed an interest in manufacturing the subject items to the Source Development Department. The subject item is considered critical to safety of flight: therefore, additional sources must obtain engineering source approval prior to contract award. NAVICP will continue to encourage manufacturers with the expertise to manufacture the subject item to submit a complete technical data package for review and source approval by the appropriate engineering source approval authority, namely, NAVICP, NADEP or NAVAIR.
