“NAVSUP Weapon Systems Support Source Development Department has completed a full screen review on the subject item. The AMC/AMSC is (3C) with (20722) Entwistle Company as the only approved source of supply. The subject item is considered critical to safety of flight: therefore, additional sources must obtain engineering source approval prior to contract award. NAVSUP WSS will continue to encourage manufacturers with the expertise to manufacture the subject item to submit a complete technical data package for review and source approval by the appropriate engineering source approval authority, namely, NAVSUP WSS, NADEP or NAVAIR. Future requirements will be advertised in the FedBizOpps website ([www.fedbizopps.gov](http://www.fedbizopps.gov)) and the NAVSUP WSS Buy Requirements Listing in order to encourage potential suppliers to submit Source Approval Requests.”


