

AMC 2. Suitable for competitive acquisition for the first time.

AMSC B. This part must be acquired from a manufacturing source(s) specified on a source control or selected item drawing as defined by the current version of DoD-STD-100. Suitable technical data, Government data rights, or manufacturing knowledge are not available to permit acquisition from other sources, nor qualification testing of another part, nor use of a second source part in the intended application. Data review discloses that required data or data rights are not in Government possession and cannot be economically obtained.

This acquisition will be negotiated with:



This item is Critical Safety Item (CSI).

This acquisition will be a limited competition negotiated with Smiths Tubular Systems (78570) and General Electric (99207) because they are the only approved sources of manufacture approved by GE the DCA. The Navy does not have in its possession any manufacturing data, including manufacturing publications, supporting test equipment, and associated specifications required to produce the subject item at this time. The data needed is currently under review for procurement by NAVAIR. This item just came off the F414 PBL and will be transferring to DLA management. However DLA requires a pipe line of parts to support the Fleet until management assumption is complete. Due to this item being CSI on a Source controlled drawing, the Navy does not have sufficient data to support a full and open competitive procurement, until such time NAVSUP WSS must acquire this item from either Smiths Tubular or GE.

6. DESCRIPTION OF EFFORTS MADE TO SOLICIT OFFERS FROM AS MANY OFFERORS AS PRACTICABLE:

Market Research was conducted in accordance with FAR part 10. The results of the Market Research conducted (or the reason market research was not conducted) is as follows: *limited*

NAVSUP Weapon System Support completed a screen review on the subject item. The AMC/AMSC is (2B) with Smiths Tubular Systems (78570) and General Electric (99207) as the only approved sources of manufacture. No other sources have expressed an interest in producing the subject item to the Source Development Department at this time. Available data has been found inadequate to support full and open competitive acquisition. The subject item is considered a CSI item therefore, additional sources must obtain engineering source approval via DCA, General Electric prior to contract award.

7. DETERMINATION OF FAIR AND REASONABLE COST: The contracting officer determines that the anticipated cost to the Government of the supplies covered by this J&A will be fair and reasonable.

8. ACTIONS TO REMOVE BARRIERS TO FUTURE COMPETITION:

For reasons set forth in Paragraphs (5) & (6), NAVSUP WSS has no plans at this time to compete future contracts for the types of supplies/services covered by this document. If another potential source emerges, NAVSUP WSS will assess whether competition for future requirements is feasible.
