1. Contracting Activity

NAVSUP Fleet Logistics Center Yokosuka (FLCY), Japan

2. Description of the Action Being Approved

The requirement is to provide specific elements of husbanding services to the USS BENFOLD (DDG 65) for a port visit to Qingdao, People's Republic of China. This is an award of a contract on a sole source basis for Husbanding Services in support of USS BENFOLD (DDG 65) in Qingdao. Authority to act under this justification expires on Sept 30, 2016.

3. Description of Supplies/Services.

The husbanding service requirements requested by this vessel under LOGREQ 132201Z JUL 16 are as follows: management services, trash removal, brows, collection/holding/transfer (CHT) sewage removal and disposal, fenders, material handling, potable water, shore power, transportation, tugs, fresh potable water, pilot services, tug services, line handler services, crane services, forklift services, fenders, force protection services.

5. Rationale Justifying Use of Cited Statutory Authority

Qingdao Sinwa Ship Supply Co., Ltd. is the only authorized contractor to go in and out of the North Sea Fleet Naval Base. Failure to award this effort to Qingdao Sinwa Ship Supply Co., Ltd. will leave USS BENFOLD (DDG 65) with no husbanding services. This would have

tremendous negative impact on this vital Navy-to-Navy and U.S.-China diplomatic engagement.

6. Description of Efforts Made to Solicit Offers from as Many Offerors as Practicable

The market research conducted via the port surveys details that Qingdao Sinwa Ship Supply Co., Ltd. is the only vendor mandated by the North Sea Fleet, People's Liberation Army - Navy of the People's Republic of China to perform husbanding services in Qingdao Port. Therefore, this will be non-competition requirement there's no other potential sources available.

7. Determination of Fair and Reasonable Cost

The contracting officer has determined the anticipated cost to the US Government for services covered by this J&A will be fair and reasonable based on a comparison of fair and reasonable prices paid for similar services on previous procurements or other port visits, a comparison of proposed prices with the independent Government cost estimate and a comparison of proposed prices with the prices obtained through market research for the same or similar items.

8. Actions to Remove Barriers to Future Competition

For the reasons set forth in Paragraph 5, NAVSUP Fleet Logistic Center Yokosuka has no plans at this time to compete future contacts for the types of supplies/services covered by this document. If another potential source emerges, NAVSUP Fleet Logistic Center Yokosuka will assess whether competition for future requirements is feasible.


