1. Identification of the Agency and Contracting Activity

Department of the Navy - Strategic Weapons Facility, Atlantic located at the 1150 USS LOS ANGELES RD, Kings Bay, GA 31547-2634.

2. Nature and/or Description of the Action Being Approved

Provide on base berthing in support of operations and duty requirements for Command Duty Officer, Officer of the Day during normal working conditions and Executive Officer during operations.

The acquisition of the supplies/services particular to one manufacturer or company because only one source is reasonably available under a Sole Source Justification.

3. Description of Supplies/Services Required to Meet the Agency's Needs

On base berthing in support of SWFLANT operations.

4. Statutory Authority Permitting Brand Name Justification

This action is being executed in accordance with FAR 13.106(b)(1)(i) as only one source is reasonably available.

5. Rationale Supporting Use of the Authority

Based on protection of vital national security assets requiring supervisor elements to be on board SUBBASE 24 hours a day, 365 days a year as delineated in SWFLANTINST 1601.4H and 41MIKE (classified). It is the only facility physically located on base capable of supplying temporary berthing in support of operations and security requirements.




