The NAVSUP Weapon Systems Support (WSS) has completed a full screen review on the subject Cylinder Assembly. The AMC/AMSC is "3D" with Parker-Hannifin (82106) as the only approved source of supply. No other sources have expressed an interest in manufacturing the subject item to the Source Development Department. The subject item is considered critical to safety of flight, therefore, other sources must obtain engineering source approval prior to contract award. The NAVSUP Weapon Systems Support (WSS) will continue to encourage manufactures with the expertise to manufacture the subject item to submit a complete technical data package for review and source approval by the appropriate engineering source approval authority. Future requirements will be advertised in the FedBizOpps website (www.fedbizopps.gov) and the NAVSUP Weapon Systems Support (WSS) Buy Requirements Listing in order to encourage potential suppliers to submit Source Approval Requests.
