AMSC H. The Government physically does not have in its possession sufficient, accurate, or legible data to purchase this part from other than the current source(s). The deficiency is under review for resolution.

This acquisition will be negotiated with: Northrop Grumman Systems Corporation (70974)

The items that are to be procured under this acquisition are for Interim Supply Support (ISS) of the E2D Advanced Hawkeye. ISS items are considered design unstable as no formal configuration baseline has been established. One of the critical functions of the interim support phase is designed to determine a baseline configuration, which impacts maintenance requirements and logistical support. As the E2D aircraft is currently in the interim support phase of the life cycle process, the aircraft is experiencing constant anomalies and variance within the configuration. The government physically does not have in its possession sufficient engineering and technical data to contract for spares with other than the prime. Since the Material Support Date (MSD) is scheduled for October 01 2015, re-procurement technical data has not yet been developed, and will not be available in time to support Initial Operating Capability (IOC). It is anticipated that technical data will be provided to the Navy at a later date, at which time the technical data will be evaluated to determine if it is suitable for competition, as well as evaluating the feasibility of any other alternatives for achieving and/or enhancing competition. A criticality determination has been performed. These items are critical application items (CAI).

**6. DESCRIPTION OF EFFORTS MADE TO SOLICIT OFFERS FROM AS MANY OFFERORS AS PRACTICABLE:**

The proposed contract action was synopsised in the FedBizOpps website for government-wide point of entry on:

Market research was not conducted as the aircraft is currently in the interim phase of the life cycle process. A baseline configuration has not yet been established as the item is design unstable at this time.
