AMC 4. Acquire, for the first time, directly from the actual manufacturer.

AMSC Y. The design of this part is unstable. Engineering, manufacturing, or performance characteristics indicate that the required design objectives have not been achieved. Major changes are contemplated because the part has a low process yield or has demonstrated marginal performance during tests or service use. These changes will render the present part obsolete and unusable in its present configuration. Limited acquisition from the present source is anticipated pending configuration changes.

This acquisition will be negotiated with: PHYSICAL OPTICS CORP (0AZ36)

Only PHYSICAL OPTICS CORP (0AZ36) will be solicited because the item that is to be manufactured under this acquisition is for Interim Supply Support (ISS) of the ADTS Data Transfer Unit (DTU). NAVSUP Weapon Systems Support, Source Development Department has a breakout program designed to convert as many acquisitions as possible to full and open competition. However, the items that are to be procured under this acquisition are for Interim Supply Support (ISS) of the ADTS Data Transfer Unit (DTU). ISS items are considered design unstable as no formal configuration baseline has been established. Since the Material Support Date (MSD) is scheduled for 19001 day (01 January 2019), re-procurement technical data has not yet been developed, and will not be available in time to support Initial Operating Capability (IOC). It is anticipated that technical data will be provided to the Navy at a later date, at which time the technical data will be evaluated to determine if it is suitable for competition, as well as evaluating the feasibility of any other alternatives for achieving and/or enhancing, competition.

6. DESCRIPTION OF EFFORTS MADE TO SOLICIT OFFERS FROM AS MANY OFFERORS AS PRACTICABLE:

Market research was conducted in accordance with FAR Part 10. The results of the market research conducted are as follows: NAVSUP Weapon Systems Support (WSS) Code 03 has conducted a market research per the market research document. The AMC/AMSC is "4Y" Suitable technical data, Government data rights, or manufacturing knowledge are not available to permit acquisition from other sources, nor qualification testing of another part, nor use of a second source part in the intended application. Data rights are not in Government possession and cannot be obtained as the design of subject item is unstable. Currently the only approved sources of supply are PHYSICAL OPTICS CORP (0AZ36). No other sources have are authorized to manufacturing subject item as this item is unstable meaning that the design is subject to change and cannot be disseminated for mass production to multiple companies. In Addition no companies have expressed an interest in producing this item to the source development department.

7. DETERMINATION OF FAIR AND REASONABLE COST: The contracting officer determines that the anticipated cost to the Government of the supplies covered by this J&A will be fair and reasonable.

8. ACTIONS TO REMOVE BARRIERS TO FUTURE COMPETITION:

For reasons set forth in Paragraph (5) & (6), NAVSUP WSS has no plans at this time to compete future contracts for the types of supplies/ services covered by this document. If another potential source emerges, NAVSUP WSS will assess whether competition for future requirements is feasible.
