This item is a non-critical safety item.

This acquisition will be a limited competition negotiated with Labarge Electronics (16275), Unison Industries (59501) and General Electric (99207) because they are the only approved sources of manufacture approved on the source controlled drawing by GE. GE has proprietary rights this information because they are the DCA. All alternate sources must qualify IAW the DCA's procedures, as approved by NAVAIR prior to contract award. Vendor substantiation is required. The Navy does not have in its possession any manufacturing data, including manufacturing publications, supporting test equipment, and associated specifications required to produce the subject item at this time. The data needed was under review for procurement however GE refused to release any data at this time. This item recently came off the F414 PBL and will be transferring to DLA management. However DLA requires a pipe line of parts to support the Fleet until management assumption is complete. Due to this item being on a Source controlled drawing, the Navy does not have sufficient data to support a full and open competitive procurement, until such time NAVSUP WSS must acquire this item from the approved sources on the drawing.

**6. DESCRIPTION OF EFFORTS MADE TO SOLICIT OFFERS FROM AS MANY OFFERORS AS PRACTICABLE:** The proposed contract action was synopsisized and included a Sources Sought Notice on the FedBizOpps website for government-wide point of entry on

Market Research was conducted in accordance with FAR part 10. The results of the Market Research conducted (or the reason market research was not conducted) is as follows:

NAVSUP Weapon System Support completed a limited screen review on the subject item. The AMC/AMSC is (2B) with Labarge Electronics (16275), Unison Industries (59501) and General Electric (99207) as the only approved sources of manufacture. No other sources have expressed an interest in producing the subject item to the Source Development Department at this time. Available data has been found inadequate to support full and open competitive acquisition and vendor substantiation is required. The subject item is considered a Non- CSI item however, GE has proprietary rights to the data and additional sources must obtain engineering source approval via DCA, General Electric prior to contract award.

**7. DETERMINATION OF FAIR AND REASONABLE COST:** The contracting officer determines that the anticipated cost to the Government of the supplies covered by this J&A will be fair and reasonable.

**8. ACTIONS TO REMOVE BARRIERS TO FUTURE COMPETITION:**

For reasons set forth in Paragraphs (5) & (6), NAVSUP WSS has no plans at this time to fully compete future contracts for the types of supplies/services covered by this document. If another potential source emerges, NAVSUP WSS will assess whether competition for future requirements is feasible.
