6. **FEDERAL BUSINESS OPPORTUNITIES/POTENTIAL SOURCES:** The proposed contract was/will be synopsisized in the FedBizOpps website for government wide point of entry.

11. **ACTIONS TO REMOVE BARRIERS TO COMPETITION:**

The AMC/AMSC of the subject item; Link Assembly, Aft Nacelle is (3C) with Bell Helicopter/Textron, Inc. (97499) as the only approved source of supply. No other sources have expressed an interest in manufacturing the subject item to the Source Development Department. Available data has not been found adequate to support competitive acquisition. The subject item is considered critical to safety of flight, therefore, additional sources must obtain engineering source approval prior to contract award. NAVSUP WSS and the DLA Philadelphia Competition Advocate will continue to encourage manufacturers with the expertise to manufacture the subject item to submit a complete technical data package for review and source approval by the appropriate engineering source approval authority, namely, NAVSUP WSS, NADEP or NAVAIR. Future requirements will be advertised in the Fed Biz Opps website (www.fedbizopps.gov) and the NAVSUP WSS Buy Requirements Listing in order to encourage potential suppliers to submit Source Approval Requests.


