5. DEMONSTRATION OF CONTRACTORS UNIQUE QUALIFICATIONS: The current Acquisition Method Code (AMC/AMSC) is 2B. This acquisition will be negotiated with BELL HELICOPTER 97499 and AMETEK TERMAL SYSTEMS INC 12536 PN 60670-000-1

Only the above will be solicited because the articles to be acquired are highly specialized parts, designed and manufactured by a non-Government activity and the technical data required for acquisition by other than the above is not available.






