2. Contractor SHALL submit Production Drawings/Models and Associated Lists in accordance with DD1423, sequence number A001.

**SECTION C – INERTING INSTRUCTIONS FOR CARTRIDGES/CARTRIDGE ACTUATED DEVICES (CAD/PAD)**

INERT CTGs/CAD/PADs are **non-explosive** devices used as training aides. Design requirements for INERTS are to ensure high confidence for the training community that no explosive hazards are present. The following instructions provide the unique INERT manufacturing steps.

1. ANODIZING/PAINTING OF INERTS - INERT CTGs/CAD/PADs shall be light blue, in accordance with FED-STD-595 Rev. C, Color 35109, by dyeing during anodization or painting. Anodizing or painting shall not cause the INERT to exceed the external maximum dimensions specified on the item drawing.

- a. Aluminum CTGs/CAD/PADs shall be anodized in accordance with MIL-A-8625 Rev. F, Type II, Class 2. The FED-STD-595 Rev. C, color chip shall be used for approximate comparison only.
- b. Non-aluminum CTGs/CAD/PADs or exposed components shall be painted in accordance with MIL-F-18264 Rev. D, Amendment 2. Mask all electrical connections, threads and surfaces used for mating (such as breech interfaces); although the INERT shall be painted blue on some portion of the exterior.

2. ASSEMBLY OF INERTS - INERT CTGs/CAD/PADs shall be manufactured using components meeting design and dimensional requirements of the explosive loaded devices represented.

- a. INERT CADs which normally contain cartridges shall omit the cartridge.
- b. INERT CTGs/CAD/PADs shall have four holes drilled through the area(s) that normally contain the explosive main charge. The four holes shall be 1/4 inch in diameter and be located 90° apart. A device deemed too small for the 1/4 inch holes shall contain a like number or fewer holes of a smaller diameter commensurate with the device's size and shape.
- c. INERT CTGs/CAD/PADs shall have all assembly operations (i.e. crimping, case tapering, staking, torquing, and sealing) performed to ensure proper form and appearance. The assembly shall include closure disks. These operations shall ensure that all external drawing dimensions are met.
- d. Mechanical/Pressure/Explosive Actuated INERT CTGs/CAD/PADs shall not contain Percussion Primers/Ignition Devices. Resulting holes shall not be sealed. Remove associated hardware that may

become loose without the presence of the Percussion Primer/Ignition Device.

- e. Electrically Actuated INERT CTGs/CAD/PADs shall not contain a bridgewire(s) and shall indicate an open circuit when tested for continuity. Exceptions shall be water activated devices which shall contain bridgewires for circuit testing.
  - f. INERT CTGs/CAD/PADs with Ignition Elements shall ensure the Ignition Element is INERT, properly mates with the system electrical connector, and contains electrical pins and glass-to-metal seals.
3. IDENTIFICATION OF INERTS - Marking shall be controlled to prevent identification of the INERT as the explosive loaded CTG/CAD/PAD.
- a. INERT CTGs/CAD/PADs shall be impression stamped or electro-etched with the word "INERT", an unique INERT serial number, and the item nomenclature. The unique INERT serial number will be supplied by the procuring agency at time of award.
  - b. Words pertaining to explosive devices such as "Explosive" or Propellant" shall be omitted.
  - c. Warning Labels shall be omitted from the INERT CTG/CAD/PAD.
  - d. Flow arrows shall be maintained in the correct orientation.
4. INERT FINAL INSPECTION
- a. Units are INERT (contain no explosives or residue)
  - b. Units do not exceed the external drawing dimensions
  - c. Units have the proper INERT markings and identifications
5. PACKAGING AND SHIPPING
- a. Packaging: INERT CTGs/CAD/PADs shall be packaged in commercial packaging with a tight pack.

4. Traceable Seals for shipping containers:
  - a. Traceable seals are required for delivery of all "ready to issue" (condition code A, B, C, or N) or "pending acceptance" (condition code D) ammunition and ordnance items, including inert configuration items. Traceable seals provide an indication of security and certification of material serviceability and apply to more than just hazardous materials.
  - b. The Contractor shall ensure traceable seals are properly affixed in accordance with these requirements:
    1. Traceable seals are applied to each shipping and storage container at the time of packaging. The shipping container will normally be the outer container.
    2. WIRE SEALS: A wire seal is a wire length with an aluminum disk or pellet which is crimped or crushed using a die which imprints a "U.S." symbol on the disk/pellet. Wire seals are applied to containers having provisions or means for application of wire seals, e.g., metal containers, drums, or cradles and wood boxes with hinged covers and/or latches.
    3. LABEL SEALS: A label seal is a nonmetallic label with a pressure sensitive backing and which is printed or stamped with a "U.S" symbol. Label seals are applied to containers which do not have provisions or means for application of wire seals, e.g., fiberboard or wood boxes without hasps or latches.
    4. Label seals shall be applied such that the label must be cut or defaced in order to open a container. Adhesives shall adhere well enough to prevent peeling during shipping conditions and well enough to prevent lifting and replacement of the label. Particular consideration shall be given to label seals required to adhere to wood and fiberboard surfaces.
5. Restrictions Involving Non-Manufactured Wood Packaging (NMWP) and Pallets (per Defense Logistics Agency Directive subpart 47.305-1(c)(90): "All wooden pallets and wood containers produced of non-manufactured wood shall be constructed from Heat Treated (HT to 56 degrees Centigrade for 30 minutes) material and certified by an accredited agency recognized by the American Lumber Standards Committee (ALSC) in accordance with Non-manufactured Wood Packing Policy and Non-manufactured Wood Packing Enforcement Regulations, both dated May 30, 2001."

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

Type designation means a combination of letters and numerals assigned by the Government to a major end item, assembly or subassembly, as appropriate, to provide a convenient means of differentiating between items having the same basic name and to indicate modifications and changes thereto.

Unique item identifier means a set of data elements marked on items that is globally unique and unambiguous. The term includes a concatenated unique item identifier or a DoD recognized unique identification equivalent.

Unique item identifier type means a designator to indicate which method of uniquely identifying a part has been used. The current list of accepted unique item identifier types is maintained at [http://www.acq.osd.mil/dpap/pdi/uid/uii\\_types.html](http://www.acq.osd.mil/dpap/pdi/uid/uii_types.html).

(iv) of this clause for which the contractor creates and marks a unique item identifier for traceability.

(2) The unique item identifier assignment and its component data element combination shall not be duplicated on any other item marked or registered in the DoD Item Unique Identification Registry by the contractor.

(3) The unique item identifier component data elements shall be marked on an item using two dimensional data matrix symbology that complies with ISO/IEC International Standard 16022, Information technology--International symbology specification--Data matrix; ECC200 data matrix specification.

(5) Unique item identifier.
