The following have been added by full text:

AMENDMENT 0006

Amendment 0006 has incorporated changes to “ADDENDUM TO 52.212-1”, paragraph “(2) Volume II – Price/Cost.” See Summary of Changes.

The following paragraph of the PWS has been modified –

“Laundry Service for Linens and Uniforms.”

The government shall provide all tablecloths, cloth napkins and other linens required for wardroom or catering service. These linens shall be laundered through the Naval Academy laundry facility, at the government’s expense. The Service Provider will be responsible for ensuring linens are picked up/delivered in a timely manner. The Service Provider does not transport the linens. Linens should be stored in a manner that prevents damage and mildew.”

The following question was asked as part of Amendment 0003, “Could the Government please provide a list of illnesses that would exclude an employee from working in the food service department and should therefore be tested for those acute and chronic diseases to ensure compliance with the physical examination requirement?” This information is found in the applicable instruction, NAVMED P-5010-1.

The PWS has been changed as set forth above. It has been determined that the solicitation is clear on its face or clear per any applicable instruction, i.e. “ NAVMED P-5010-1.”

The following have been modified:

ADDENDUM TO 52.212-1

I. GENERAL

(2) Volume II – Price/Cost

Volume II shall include the completed solicitation and pricing information sufficient to establish compliance with the Service Contract Labor Standards, formerly the Service Contract Act. The cost and pricing information shall be completed in accordance with the following:

(a) Direct labor price breakdown showing labor categories and direct labor rates, as well as non-labor costs, i.e. ODCs. The Government is not soliciting a breakdown of the offeror’s indirect rates/profit. The price breakdown of labor rates and other direct costs will NOT be used to conduct a price realism analysis.

(b) For proposal purposes, the following ratios of On-site (Contractor facility) and Off-site (Government facility) labor performance are established for all labor categories:

ON-SITE	OFF-SITE
0 %	100%

(c) Any and all subcontracts identified in the Non-price proposal shall be identified and priced in the price/cost proposal.
