Q. Can the Page Limitation be increased?

A. The page limit will not be increased.

Q. Can a list of equipment be provided so that offerors can understand the scope of the equipment they will be responsible to clean?

A. Government provides for dining hall and catering room spaces, tables, chairs, hot carts, plates/utensils, commercial dishwashing machines, trash cans, food grinder

The only item that would require a preventative maintenance plan would be the dishwashers.

Q. Why is the contract being recompeted?

A. This question is not relevant to the submission of proposals for this RFP.

Q. TE.3 Meal hours. What is the length of the meal period for Sunday Dinner and Monday through Friday Breakfast and Lunch? The TE shows what appears to be the start time but does not provide when the period ends. Will the Government please clarify this issue?

A. Sunday dinner is 1700-1900. Mon-Fri breakfast is 0630-0800, lunch is 1130-1300.

Q. PWS page 26, Government Provided Supplies, states "On the contract start date, the Government will provide the Service Provider the expendable and non-expendable supplies listed herein. Listed items are a representative record of supplies used in the course of normal operations, but it does not guarantee an

item to be in stock.” What is meant by the statement that it does not guarantee an item to be in stock?
What is the service provider to when a needed government provided item is not available?

A. The Government provides cleaning and other expendable supplies to the service provider; however, in rare events those items may not be in stock (i.e. Government shutdown or major budget shortfalls due to congressional actions, failed delivery from suppliers, etc.). In that case the service provider would not be held responsible for tasks not completed if they were contingent on Government resources.

Q. Is the Service Provider only responsible for the repairs of dishwashers?

A. Yes

Q. What is meant by “associated equipment”?

A. Anything that goes on or in the dishwashers that are required for operation (i.e. baskets, belts, detergent dispensers, etc.)

Q. Is there any other government equipment that the service provider is responsible to repair?

A. No.

If so, can we be provided a listing of that equipment and can the government provide historical information regarding the cost of repairs for each piece of equipment?

Not Applicable.

Q. Is there a specific area for service provider employee parking?

A. There is no specific area for parking.
