PERFORMANCE WORK STATEMENT

Performance Work Statement

Mexican Armed Forces Training

American University Washington College of Law, Academy on Human Rights and Humanitarian Law – Program of Advanced Studies on Human Rights & Humanitarian Law

1. Scope:

This establishes the tasks necessary for training support provided to the Government of Mexico International Military Students (IMS) in the Human Rights and Humanitarian Law Program. The period of performance is 13 weeks starting from 25 April 2016 and ending 29 July 2016.

2. Requirements:

American University Washington College of Law, Academy on Human Rights and Humanitarian Law shall provide the following in support of training for ten (10) military students from Mexico:

2.1 Training Course Program

Overview: This is a summer training curriculum in advanced Human Rights and Humanitarian law studies taught in Spanish.

Description: The 2016 Program begins 30 May 2016 and ends 17 June 2016. Courses of instruction will be in accordance with the descriptions included in paragraph 3. Courses can be pursued for a Diploma or for a Certificate of Attendance. Persons pursuing the Diploma must have a law degree and complete a minimum of three courses. Mandatory exams are to be completed on-line by the students in Mexico after completion of the training courses.

2.2 Student Billeting During Training Program

Overview: American University will provide on-site billeting for students during the summer academic session. Billeting required from day of arrival 29 May 2016 until day of departure 18 June. (Total of 20 nights billeting per student).

3.0 Human Rights and Humanitarian Law courses of instruction (In Spanish):

3.1 INTERNATIONAL HUMANITARIAN LAW

Description: The course "International Humanitarian Law" aims to provide a basic understanding of humanitarian law from recent armed conflicts and other global events of recent years. Topics such as the principle of limitation in international armed conflicts, war crimes, theories of war, wars in the world today, and some studies of armed conflicts will be, among others, some of the topics covered in class. With this perspective the existing legal corpus in this area and the challenges before which is facing the current international law of armed conflict will occur.

3.2 ECONOMIC, SOCIAL AND CULTURAL RIGHTS

Description: The course will cover the content and contemporary developments in economic, social and cultural rights. During the course the scope of state obligations, protection mechanisms, justiciability of these rights, with specific examples concerning rights such as the rights to health, education, housing, employment and food will be discussed.

3.3 IMPLEMENTATION OF HUMAN RIGHTS IN DOMESTIC LAW

Description: This specialized course is aimed primarily at public officials in the executive, legislative and judicial branches of States. Participants will explore in depth the relevant aspects of the interaction between internationally and domestically human rights, providing them with concepts for the design of public policies on human rights or to interpret and apply standards in the framework of the rights tools human.

3.4 IMPUNITY AND INTERNATIONAL JUSTICE

Description : In 1998 was adopted at a conference of plenipotentiaries in the City of Rome Statute creating the International Criminal Court (the "CPI"). The ICC will have complementary jurisdiction to the national criminal courts and investigate and punish the perpetrators of the worst crimes of humanity, namely genocide, crimes against humanity and war crimes. It is the first permanent international criminal court that serve to combat impunity and to prevent future serious violations of human rights and international humanitarian law, as it will act when states are unwilling or unable to fulfill its primary obligation to investigate, prosecute and appropriate sanction suspected of committing such crimes. It will also be a mechanism to help victims of crime and their families to seek compensation for damage.

Overall objective:

This course module aims to introduce students to the International Criminal Court from the study and discussion of its Statute, Elements of Crimes, Rules of Procedure and Evidence and documents prepared by doctrinaire and NGOs. During various topics will be addressed and abound in the more controversial, especially those related to its competence and jurisdiction. Upon completion of this course the student should clearly identify the scope of the jurisdiction of the ICC on grounds of person, time, place and matter; the same composition and the way in which work organs. Also, will discuss the various legal problems encountered in some countries and that hindered the ratification and the ways how they were resolved by certain countries. Finally, the challenges of implementing the Rome Statute in the field of domestic law of States Parties, as well as remaining goals will be analyzed so that the Court can function complementarily effective, impartial and independent manner.

3.5 FREEDOM OF EXPRESSION

Description: This course exposes the constituent elements of the Human Right to Freedom of Expression and its correlative rights of free association and access to information. The course aims to explore the particular importance of freedom of expression within democratic systems of government and its various protection mechanisms both in domestic jurisdictions, and international jurisdiction.

In parallel to the analysis of important readings on the subject, several international cases in which we analyzed the scope of this right and the content of the obligations under international human rights law requires States to ensure respect be studied and implementation of this right. In this sense, the course explores the limits on protecting freedom of expression, the reasons why an expression deserves protection and balance freedom of expression with other fundamental rights or public interests. Will be special reference to inter-American human rights protection in particular, and within this , the mission of the Special Rapporteur for Freedom of Expression. Also, the system of the United Nations and the Special Rapporteur within the same scan.

3.6 LITIGATION AND HUMAN RIGHTS ACTIVISM

Description: The course provides different perspectives on international and national human rights activism, the role of non-governmental organizations and the importance of international monitoring mechanisms. The role of non -state actors in the development of international law on human rights and the importance of legal mechanisms in the work of human rights activist will be explored. International litigation techniques, strategies and tactics, and the role of the parties to a dispute and awarding bodies will also be addressed. The importance of the interaction between the domestic and the international level both in terms of activism as in the area of human rights litigation will also be explored.

3.7 WOMEN AND INTERNATIONAL LAW OF HUMAN RIGHTS

Description: This course explores the international framework of human rights , and how this applies or should be applied to ensure human rights for women . Major international and regional conventions will be examined, with emphasis on the inter-American system. Existing case law and the recommendations of the committees monitoring UN has helped to articulate protections for women's rights will be discussed. The role of various governmental and nongovernmental organizations in the process of creation and implementation of this policy framework actors will be examined.

3.8 HUMAN RIGHTS SYSTEM OF THE UNITED NATIONS

Description: The conventional mechanisms have a universally important in monitoring situations and cases of human rights violation weight. The creation of these mechanisms is not derived from a treaty or international agreement but decisions (resolutions) issued by organs of the United Nations General Assembly , the Security Council , the Economic and Social Council (ECOSOC) or the Commission Human rights or specialized agencies, such as the International Labour Organization (ILO) and the United Nations Fund for Children (UNICEF) , among others. The range of mechanisms is arborescentemente broad both in design and specific mandates as its source the creation in 1993 of the institution of the United Nations Human Rights Council was an important step by the General Assembly opened a field of possibilities for the protection of human rights which still awaits concretions and further developments. The course seeks to analyze this rich and intense dynamics from both analytical and practical approach.

3.9 INTER-AMERICAN SYSTEM OF HUMAN RIGHTS

Description: This course will cover the development of human rights in the inter-American system and the way in which the Inter-American Commission on Human Rights and the Inter-American Court of Human Rights protect those rights within their respective mandates. The analysis of the Commission's work will focus on the system of individual petitions, on-site visits, special reports on countries that are part of the system and thematic reports of the various rapporteurs. Among the topics to be discussed when analyzing the Commission are the presentation and processing of individual petitions and how protects the rights recognized in various instruments of the system. Regarding the Court, its contentious and advisory jurisdiction will be discussed, highlighting the progress made in its most recent case law. In practical terms, this section will examine the question of the effectiveness of the system, including how they work the same can be translated into strategies that will integrate at national level, where ultimately the protection afforded by it to take effect.

CLAUSES INCORPORATED BY FULL TEXT

52.212-4 CONTRACT TERMS AND CONDITIONS-- COMMERCIAL ITEMS (MAY 2015)

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to 41 U.S.C. chapter 71, "Contract Disputes", as amended (41 U.S.C. 601-613). Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement or any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include--

(i) Name and address of the Contractor;

(ii) Invoice date and number;

(iii) Contract number, contract line item number and, if applicable, the order number;

(iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;

(v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;

(vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;

(viii) Name, title, and phone number of person to notify in event of defective invoice; and

(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer--Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.--

- (1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.
- (2) Prompt payment. The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.
- (3) Electronic Funds Transfer (EFT). If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.
- (4) Discount. In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.
- (5) Overpayments. If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall--
- (i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the--
 - (A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);
 - (B) Affected contract number and delivery order number, if applicable;
 - (C) Affected contract line item or subline item, if applicable; and
 - (D) Contractor point of contact.
 - (ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.
- (6) Interest.
- (i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.
 - (ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.
 - (iii) Final decisions. The Contracting Officer will issue a final decision as required by 33.211 if--
 - (A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;
 - (B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or
 - (C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

- (iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.
- (v) Amounts shall be due at the earliest of the following dates:
- (A) The date fixed under this contract.
 - (B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.
- (vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on--
- (A) The date on which the designated office receives payment from the Contractor;
 - (B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or
 - (C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.
- (vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.
- (j) Risk of loss. Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:
- (1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or
 - (2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.
- (k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.
- (l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.
- (m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.
- (n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) Compliance with laws unique to Government contracts. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) Order of precedence. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order: (1) the schedule of supplies/services; (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause; (3) the clause at 52.212-5; (4) addenda to this solicitation or contract, including any license agreements for computer software; (5) solicitation provisions if this is a solicitation; (6) other paragraphs of this clause; (7) the Standard Form 1449; (8) other documents, exhibits, and attachments; and (9) the specification.

(t) System for Award Management (SAM). (1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(u) Unauthorized Obligations.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.
