1.0 BACKGROUND

1.1 The Virginia Class submarine USS Hawaii (SSN-776) has one (1) Secondary Propulsion System. The SPS consists of a Secondary Propulsion Unit (SPU) and a Rotational Deployment Mechanism (RDM). The RDM enables the SPU to deploy, train, and retract. An RDM hydraulic motor drives the training motion of the SPU.

2.0 OBJECTIVE AND SCOPE

- 2.1 This Performance Work Statement (PWS) provides for the procurement of one (1) Rotational Deployment Mechanism (RDM) Refurbishment Kit for the SSN 776 (SPS). Supplies and long lead time items provided under this contract shall be initiated by Curtiss-Wright EMD upon receipt of contract in order to support completion of refurbishment and receipt of RDM by PHNSY & IMF.
- 2.2 Supplies will be inspected and accepted at the contractor's facility. Disposition and/or transportation will be determined after contract award.

3.0 PERFORMANCE REQUIREMENTS

- 3.1 The contractor shall provide the following material services:
- 3.1.1 Procurement of RDM Refurbishment Kit to support refurbishment of one (1) RDM assembly. See Enclosure (1) of this PWS for a listing that comprise one (1) kit.
