

This is a COMBINED SYNOPSIS/SOLICITATION for commercial items prepared in accordance with the information in FAR Subpart 12.6, using Simplified Acquisition Procedures under the test program for commercial items found at FAR 13.5, as supplemented with the additional information included in this notice. This announcement constitutes the only solicitation; a written solicitation will not be issued. PAPER COPIES OF THIS SOLICITATION WILL NOT BE AVAILABLE. This combined synopsis/solicitation SHALL be posted on FEDBIZOPPS, and NECO (<https://www.neco.navy.mil/>).

The RFQ number is N00604-16-T-3011. This solicitation documents and incorporates provisions and clauses in effect through FAC 2005-85 and DFARS Publication Notice DPN 20151230. Quoters are reminded to include with their quotes the following, as well as any additional information and certifications with reference to the provisions contained herein:

- 1) A unit price per each foot of pipe, Total Price, FOB point, a point of contact, name and phone number, business size, and payment terms. Each response must clearly indicate the capability of the quoter to meet all specifications and requirements.
- 2) A completed copy of 52.212-3 and its ALT I (Attachment I). If the quoter has completed the annual representations and certification electronically via the System for Award Management (SAM) Web Site, the quoter shall only complete paragraph (b) of this provision.
- 3) DFARS 252.209-7991 (Attachment II) Unpaid Delinquent Tax Liability Provision.

Basis of Award: This requirement will be awarded to the quoter with the lowest price technically acceptable (LPTA) for Total Price. Technical acceptability will be contingent upon the quoter proposing to meet all requirements in the RFQ.
