AED	Arab Emirates Dirham.
Annual Rate	Covers 365 calendar days.
Cargo Trucks	A cargo truck with enclosed cargo bed, capable of hauling 3 tons of baggage. Must be Toyota, Mitsubishi, or similar make.
Ex-fleet / Used Vehicles	Vehicles must be no more than two years old, and have no more than 30,000 kilometers on the odometer upon delivery.
Extended Length Sports Utility Vehicle (SUV)	An extended length SUV, also sometimes called a long-wheel based SUV, are vehicles that are similar to a full-size SUV, except that these vehicles have a larger cargo area (around 130 in (3.30 m)) and passenger space that can seat up to 8 or 9 people (with the available third row seating that when folded or removed adds more cargo space). The vehicles are 221 in (5.61 m) to 223 in (5.66 m) in length and can be distinguished by the rear wheel area not touching the rear doors. Fifteen (15) Passenger Van	A large vehicle that is characterized by a large boxy appearance, short hood, and very heavy cargo / passenger hauling capacity. Vehicle features a power train, automatic transmission and rear wheel drive. Engine is 4/6-cylinder type. Typical wheel base dimensions are between 124 inches (3,149 mm) and 135 inches (3,429 mm). Example vehicles include: <ul style="list-style-type: none"> <li>- Ford E-Series</li> <li>- GMC Savanna</li> <li>- Chevrolet Express</li> </ul>
Full Size Pickup Truck	A large pickup truck suitable for hauling heavy loads and performing other functions. Most full-size trucks can carry at least 1,000 lb (450 kg) in the rear bed with some capable of over six times that much. Engine is 6/8-cylinder type. Typical wheel base dimensions are between 124 inches (3,149 mm) and 148 inches (3,759 mm). Example vehicles include: <ul style="list-style-type: none"> <li>- Chevrolet Silverado</li> <li>- Ford F-Series</li> <li>- Nissan Titan</li> <li>- Toyota Tundra</li> </ul>
Full Size Sedan	Passenger sedan vehicles usually having wheelbases greater than 110 inches (2,794 mm) and interior volume 120 cubic feet or greater. Engine is 6-cylinder type. Example vehicles include: <ul style="list-style-type: none"> <li>- Ford Taurus</li> <li>- Chevrolet Impala</li> <li>- Honda Accord</li> </ul>
Full-Size Sport Utility Vehicle (SUV)	Also referred to as a standard SUV. A vehicle similar to a station wagon, but built on a light-truck chassis, usually equipped with four-wheel drive for on- off-road ability, and with some pretension or ability to be used as an off-road vehicle. Engine is a minimum V-6/3.5L. Typical wheel base dimensions are between 116 inches (2,946 mm) and 119 inches (3,023 mm). Example vehicles include: <ul style="list-style-type: none"> <li>- Chevrolet Tahoe</li> <li>- Ford Expedition</li> <li>- Toyota Land Cruiser</li> </ul>
Government Dispatch Points	Located at any of the various sites as identified by the KO.

Seven (7) Passenger Van	A mid-size vehicle that is characterized by a boxy appearance, short hood, and cargo / passenger hauling capacity. Thirty (30) Passenger Bus	Midibus, generally larger than a traditional minibus but smaller than a full-size single decker and can be anywhere between 26-feet 3-inches (8 meters) and 36-feet 1-inch long (11 meters), with 30-35 seats. Example vehicles include: <ul style="list-style-type: none"> <li>- Toyota Coaster</li> </ul>
Twenty-Four Hour Schedule (24/7)	Is defined as a minimum of two (2) drivers on 12-hour shift and covering a total of 24-hour period per day, 7 days a week, including US and UAE holidays.
Twelve Hour Schedule (12/7)	Is defined as a minimum of one (1) driver covering a total of 12-hour period per day (typically from 0700 to 1900 hrs), 7 days a week, including US and UAE holidays.
