A firm fixed proposed price is required for Items CLIN 0001, CLIN 0002, CLIN 0003 and CLIN 0004. No provision is made for economic price adjustment. If Options are exercised, the contract completion date remains 555 calendar days after award of the contract”.*

**REPLACE** with:

*“The Government reserves the unilateral right to award items CLIN 0002, CLIN 0003, and CLIN 0004 and will either be exercised at time of award or not at all. A firm fixed proposed price is required for items CLIN 0001, CLIN 0002, CLIN 0003 and CLIN 0004. No provision is made for economic price adjustment. If Options are exercised, the contract completion date remains 555 calendar days after award of the contract”.*
