The enhanced operator suite work includes, but is not limited to, providing the following individual HMIs in the operator suite: One Power Plant Control monitor, one Running Motor-Generator Control monitor, one Running Diesel Generator Control monitor, one Base Feeder Control monitor, one Static Frequency Converter Control monitor and additional training software in accordance with the drawings and specifications. Construction of the enhanced operator suite requires the provision and installation of additional equipment (beyond that included in CLIN 0004) to include items such as control cabinets, central processing units, sensors, indicators, switches, workstations, conduits, junction boxes, and the communication cabling connecting these devices together. Work on the motor-generator cooling water system includes, but is not limited to, the addition of flow rate, chlorine level, tank level and conductivity remote indicators for the system, in accordance with the drawings and specifications, but excluding work described in CLIN 0001, CLIN 0002, CLIN 0003 and CLIN 0004.	\$ _____
