The subject solicitation is amended as follows:

- (2) ALL potential attendees are required to prepare and submit Attachment (1) SECNAV 5512/1 (April 2014) to gain base access. CAC eligible and NCACS (RAPIDGate) participants and enrollees are exempt.
- (3) All forms must be submitted to Mr. Varela (cc: Ms. Kowalski) via email by Thursday, March 12, 2015 at 3:00 PM PST.
- (4) This form will be forwarded to Base Pass and ID office, which will process a criminal background check of each potential attendee.
- (5) Photos are not permitted anywhere on base without a camera pass. Camera pass requests must be prepared using Attachment (2) and submitted to Mr. Varela (cc: Ms. Kowalski) at the same time as the security form mentioned above.
- (6) On the day of the site visit, all contractors/attendees will meet with the Government team in Bldg. 230 for a brief Pre-Proposal conference followed by visits to the sites. Two site visits will be held on March 24th, one for the subject solicitation, and one for N62473-15-T-4206. They will be held one after the other (i.e. back-to-back).
- (7) The proposal due date remains unchanged at 1:00 PM PST Friday, April 3, 2015.
