FRONT END REVISIONS - NARRATIVE

1. Document 00202, paragraph 2.2 Non-Price Evaluation Factors, PHASE I, Factor 3 – Performance Confidence Assessment (Past Performance), subparagraph (a) Solicitation Submittal Requirements, 1st paragraph, is amended to delete the last three sentences and to replace them with the following:

“It shall not be from the designer on a design-build project nor shall it be from a prime contractor to a sub-contractor. The Offeror should provide completed Past Performance Questionnaires (PPQ) in the proposal. Offeror’s may submit PPQs previously submitted for other solicitations.”
