QUESTION & ANSWER

Questions and Answers:

1.) What is the required frequency of the employee physical examination? The PWS states "The Contractor shall be responsible for the cost and completion of initial and subsequent physical examinations for contract employees."

A: 1.) All employees will have a physical examination at the start of the contract and new hires are required to have a physical examination prior to starting work under the proposed contract;

2.) On the Wage Determination, there is a note on the Executive Order 13658 establishing the minimum wage at \$10.10. Please confirm that this is the wage we have to bid at, not the individual rates listed next to occupation.

A: Please read the complete Note: Executive Order (EO) 13658 establishes an hourly minimum wage of \$10.10 for 2015 that applies to all contracts subject to the Service Contract Act for which the solicitation is issued on or after January 1, 2015. If this contract is covered by the EO, the contractor **must pay all workers in any classification listed on this wage determination at least \$10.10** (or the applicable wage rate listed on this wage determination, if it is higher) for all hours spent performing on the contract. The EO minimum wage rate will be adjusted annually. Additional information on contractor requirements and worker protections under the EO is available at www.dol.gov/whd/govcontracts.

3.) The Department of Labor released the new Health & Welfare rate on June 30, 2015 (notice attached). The new rate is now \$4.27, whereas the Wage Determination you released with the solicitation says \$4.02. Please advise whether we should use the new rate or the old rate.

A: The updated Health and Welfare Fringes Benefit Rates will be \$4.27 in lieu of \$4.02 per hour.
