C.1. DEFINITIONS AND/OR ACRONYMS:

CONTRACTING OFFICER - Representative of the Government authorized to execute Contracts.

COR - Contracting Officer Representative

NTR – Contracting Technical Representative

BILINGUAL: English, verbal and/or written

ESC- The Expeditionary Service Contractor

PN – Partner Nation

C.2. OBJECTIVE:

The primary objective of this contract is to obtain expeditionary Logistic Support for hotel services and Partner Nation (PN) Forces and their designated personnel operating ashore in Panama during the UNITAS 2016 Execution from 18-28 September 2016. Support for the exercise will be from 12-30 September 2016.

C.3. SCOPE:

COMUSNAVSO requires lodging, meals, ground transportation for PN personnel, conference rooms, tables, chairs, projector screens, conference drinks and snacks, hotel parking, communications support equipment, ground transportation, lubricating oil requirements for SENAN and simultaneous translation services in support of UNITAS 2016 Execution.

There will be four phases of UNITAS 2016 Execution. Phase I is the first in-port period from 18-21 September. Phase II is the work up phase from 22-25 September. Phase II is the Exercise Scenario Phase (ESP) from 25-26 September. Phase IV is the second in port phase from 27-28 September. PN attendees will arrive on/about 17 September, 2016 and depart on/about 28/29 September, 2016 (depending on available flights).

C.3.1. GENERAL REQUIREMENTS

The ESC shall provide lodging and meals for 22 PN personnel in Panama City, Panama for the UNITAS 2016 Execution based on provided schedule for hotels.

The ESC will provide hotel conference rooms, specific equipment to support the conference rooms, and conference drinks and snacks for PN personnel as described in detail below.

The ESC will provide simultaneous and ad hoc English-to-Spanish and Spanish-to-English translation services for specified events.

The ESC will provide communications equipment, ground transportation and lube/oil for SENAN as described to support the exercise.

C.3.1.A. HOTEL ROOM REQUIREMENTS

Hotel rooms are required for Partner Nation participants during the UNITAS 2016 Execution. The Westin Playa Bonita Hotel in Panama City must be used due to force protection concerns, conference logistics, location (vicinity to SENAN Naval HQ and Pacifico Airport), ability to support requirements and availability.

C.3.1.B. LOCATION: The hotels shall be in a safe secure location that is acceptable to United States Department of Defense security assessment. At the Westin Playa Bonita, lodging, meals, and conference rooms must be provided within the main facilities with all lodging rooms within close proximity of each other. The Westin Playa Bonita near Panama City, Panama MUST be used due to force protection, conference logistics, location, ability to support requirements, and availability.

C.3.1.E. HOTEL REPRESENTATIVE: The hotel shall provide a representative to act as a liaison with the U.S. Government logistics director. The hotel representative shall be of sufficient authority to resolve issues involving contract execution and invoicing as they arise, and will be available during the period of 12-29 September, 2016.

C.3.1.F. SERVICE BREAKDOWNS: The hotel shall ensure that any maintenance or repairs of hotel facilities, to include: guest rooms and suites, elevators, etc., will be corrected immediately at the hotel’s expense, to ensure the success of the conference and the meals served therein.

C.3.1.G. LODGING:

The Westin Playa Bonita Hotel shall provide lodging with breakfast included for Partner nation personnel in accordance with Table 1 below. Rooms will be single occupancy. Late check outs should be at no additional cost. U.S. Government may change or cancel lodging requirements to include the person designated for any room up to 24 hours prior to occupancy without penalty.

C.3.1.H. MEALS REQUIREMENTS: Lunch and dinner at the Westin Playa Bonita are required for PN participants during the conference as described below.

- A buffet lunch for PN personnel on 17-28 September based on Table 2.
- Meal vouchers shall be provided to PN personnel for dinner from 17-28 September based on Table 2. U.S. Government will not be charged for unused meal vouchers.

- Require a standard catering package for conference coffee breaks on 18-28 September from 0700-1700; and 24 hour service from 1200, 24 September to 1200, 27 September in accordance with Table 3. Coffee breaks will include: coffee (regular and decaffeinated) with creamers and assorted sugars, orange juice, hot water and assortment of teas during the morning and afternoon and evening (24-27 September) coffee break to include coffee (regular and decaffeinated) with creamers and assorted sugars, soft drinks and assorted cookies.

C.3.1.I. PARKING REQUIREMENTS: No cost parking at hotel for 50 cars for up to 24 hours/day 18-21 and 28 September and for 125 cars on 27 September for the closing reception.

C.3.1.J. CONFERENCE ROOM AND CONFERENCE SUPPORT REQUIREMENTS:

Event coordinator at hotel should be available to work with U.S. Navy conference coordinators on the afternoon/evening Saturday 17 September to ensure conference rooms are setup properly and to confirm final preparations.

- Require access to hotel Wifi for participants during the conference. Also require dedicated wireless network only for use only by conference participants in the area of the Theater, Mandarin Room, Jasmine Room, and Magnolia room with an SSID of “UNITAS16”.

- Theater (13-28 September) is available for Communications personnel to begin setup of communications systems. Designated U.S. Navy personnel will be given a key to the room and the room will remain locked at all times. A phone will be installed in the room capable of making and receiving local calls. A dedicated hardwired Ethernet connection with a static IP address and guaranteed 30Mbps will be installed in the theater.

- Mandarin Room (16-29 September) will be setup as an administrative office with tables and chairs around the perimeter of the room except for in front of the projection screen and a small table in the center of the room for a projector. Hardwire internet connections will be available for use. A phone will be installed in the room capable of making and receiving local calls. A dedicated hardwired Ethernet connection with a static IP address and guaranteed 30Mbps will be installed in the theater.

- Jasmine and Magnolia Rooms (18-21 September) will be set up in a school house format with a small table in the middle for a projector and computer. One hardwired internet connection will be available for use in each room.

- The Westin Grande 3 will be set up as follows:

1. Opening Ceremony (18 September 1000-1100): Theater setup for 150 people with a stage and podium.
 - a. 0800 - 1200: Coffee, tea, water, juice, and light snacks per *Table 3*
2. Pre-sail Conference (21 September 0900-1500): Theater setup for 100 people with a stage and podium.
 - a. 0830 - 1600: Permanent coffee, tea, water, station and morning and afternoon snacks per *Table 3*
3. Closing Reception (27 September): Banquet setup for 200 people with a stage and podium.
 - a. A separate contract will be submitted to cover the U.S. costs of the closing reception
4. Closing Ceremony (28 September 0900-1100): Setup for 200 people with a stage and podium.
 - a. 0800 - 1200 - Permanent coffee, tea, water, juice, and light snacks per *Table 3*

C.3.1.K. EXCLUSIONS: The U.S. Government will not pay for movies, mini-bars, laundry room service, telephone calls from or charged to guest rooms, or any other hotel charges other than those specifically provided for in this contract. Movies, mini-bars, laundry, service charges, etc., will be itemized separately on service bills and provided to guest participants for payment. Hotel guests will be responsible for all legitimate charges appearing on their lodging statements. *Hotel staff will inform guests during check-in which services will not be covered by the U.S. Government.* The hotel staff should request a credit card from guests upon check-in. Charges not covered by the conference are to be resolved between the guests and the hotel.

C.3.1.L. TRANSLATION SERVICES: Simultaneous translation service required for Spanish to English and English to Spanish translation during formal and informal conference meetings in the conference rooms. Translation will be required to support the breakout groups on an ad hoc basis. This includes all equipment, translators, and technicians required (sound booth, headphones, microphones, and any other required equipment). The translation equipment should support at least 50 conference attendees and up to 100 for the Opening Ceremony, Pre-sail Conference and Closing Ceremony.

The following events will require translation services:

1. 18 September 1000-1100: Opening Ceremony (sound proof booth and earpieces)
2. 18 September 1300-1400: Public Affairs meeting (face-to-face translation)

3. 18 September 1300-1600: Interdiction and Boarding Symposium (soundproof booth and earpieces)
4. 19 September 1000-1500: U.S. Coast Guard Symposium (on board USCGC MOHAWK)
5. 20 September 0900-1230: Aviation Training (at Pacifico Airfield) (face-to-face translation)
6. 21 September 0900-1500: Pre-sail Conference briefs (soundproof booth and earpieces)
7. 22-26 September 0700-1900: CECG continuous operations (face-to-face)
8. 28 September 0900-1100: Final Debrief/Lessons Learned and Closing Ceremony (soundproof booth and earpieces)

Translators will provide all equipment necessary and coordinate setup directly with the hotel. This will include all microphones, speakers, soundproof booth, earpieces, and any other required equipment.

C.3.1.M COMMUNICATIONS REQUIREMENTS

- Require twenty (20) WIFI hotspots for personnel working away from the hotel. Hotspots must be fully charged and immediately ready to use with no setup required by the user. SSIDs and passwords will be provided in an easy to read format and charged with 3GB of available data use and charged with up to 3GB more if required.
- Require ten (10) local cell phones for use by the staff away from the hotel. Dialing instructions, phone number and charger will be available at pickup and phones will be fully charged. All phones will have language set to English.

C.3.1.N. GROUND TRANSPORTATION

- Require two (2) 15 pax vans with drivers available 0400-2000 for the exclusive use by JTF-B Aviation Detachment for transportation between the Westin Playa Bonita and Pacifico Airport and any other places required to conduct official business from 15-29 September. These vans and drivers will also be on call between 2000-0400 for unforeseen emergencies or emergent maintenance support but will be given at least four hours prior notification, if possible, prior to an after-hours requirement. Drivers must have a cell phone and be able to understand basic English.
- Require two (2) 44-50 pax buses and drivers available 0700-1900 to provide transportation for UNITAS personnel to conference events listed in the SOE from 18-21 and 27-28 September. Additionally, the buses are required to support the reception on 19 September starting at 1800 onboard the ACH COMANDANTE TORO (OPV 82) at the SENAN Naval Base/PATSA Piers. Drivers must have a cell phone and be able to understand basic English.

- Require one (1) 15 pax van with drivers available 0600-2100 for the exclusive use USNAVSO UAS Detachment to conduct official business from 18-29 September. These vans and drivers will drive the UAS Detachment to Scarlet Martinez International Airport on 21 September and operate from that area until the evening of 26 September. Drivers must have a cell phone and be able to understand basic English.

- Require one (1) 15 pax van with driver available 0600-2000 for the exclusive use USNAVSO Communications team to conduct official business from 13-30 September. These vans and drivers will also be on call to support other operational requirements outside the requested hours if needed. Drivers will be given at least eight hours prior notice if needed outside those hours. Drivers must have a cell phone and be able to understand basic English.

- Require one (1) cargo van with driver available 0600-2000 for the exclusive use USNAVSO Communications team to conduct official business from 13-21 and 26-30 September. Drivers must have a cell phone and be able to understand basic English.

- Require one (1) 15 pax van and one (1) sedan with drivers available 0800-2000 for the exclusive use USNAVSO staff and subordinate commands to conduct official business from 15-29 September. Drivers must have a cell phone and be able to understand basic English.

C.3.1.O. LUBE OIL FOR SENAN BOATS: Panamá requires the types and amounts of diesel engine and gear lubricating oil in *Table 4* to be procured and delivered between 18 and 20 September to the SENAN Naval Pier for their boats participating in the UNITAS Exercise. Oil shall conform to current SAE/API specifications and delivered in 1-5 gallon containers or metric equivalents. Bulk or drum delivery is not desired. Any deviation to grade, packaging or delivery method shall be coordinated directly with the COR.

There is not a contract vehicle or payment method between the USG and Government of Panamá (GoP) to transfer DCCEP funds to the GoP for any purchases.

C.8. CONTINGENCY SITUATIONS/MISSION OPERATIONS:

Contingency situations (natural disasters, military peacetime and wartime contingency operations/exercises, serious accidents, civil disturbances, major mobilization or repatriation of non-combatants) may necessitate that the SC be flexible in arranging different levels of support and service operational hours. The SC shall respond to contingency situations and revise priorities as directed by the COR. If the SC cannot accomplish normal activities due to activation or exercise of any contingency plan, the ESC shall not be held liable for non-support of lower priorities. The COR will determine the lower priorities that can be temporarily relaxed in contingency situations. If appropriate, the SC shall be reimbursed for contingency operations requiring a higher level of response and resources. The SC shall submit a Request for Equitable Adjustment detailing the impact resulting from the incorporation and operation of such contingency actions prior to the beginning of the contingency operations. In the event that operations are curtailed as a result of weather emergencies or other unplanned mission-related events, SC personnel may be considered non-essential personnel and thus, not required to be at the work site. They may, however, be required to be on call, to work at a designated evacuation site, or to be part of a crisis response team at a nearby site.

CLAUSES INCORPORATED BY FULL TEXT

52.204-9 PERSONAL IDENTITY VERIFICATION OF CONTRACTOR PERSONNEL (JAN 2011)

(a) The Contractor shall comply with agency personal identity verification procedures identified in the contract that implement Homeland Security Presidential Directive-12 (HSPD-12), Office of Management and Budget (OMB) guidance M-05-24, and Federal Information Processing Standards Publication (FIPS PUB) Number 201.

(b) The Contractor shall account for all forms of Government-provided identification issued to the Contractor employees in connection with performance under this contract. The Contractor shall return such identification to the issuing agency at the earliest of any of the following, unless otherwise determined by the Government:

- (1) When no longer needed for contract performance.
- (2) Upon completion of the Contractor employee's employment.
- (3) Upon contract completion or termination.

(c) The Contracting Officer may delay final payment under a contract if the Contractor fails to comply with these requirements.

(d) The Contractor shall insert the substance of this clause, including this paragraph (d), in all subcontracts when the subcontractor's employees are required to have routine physical access to a Federally-controlled facility and/or routine access to a Federally-controlled information system. It shall be the responsibility of the prime Contractor to return such identification to the issuing agency in accordance with the terms set forth in paragraph (b) of this section, unless otherwise approved in writing by the Contracting Officer.

52.209-11 REPRESENTATION BY CORPORATIONS REGARDING DELINQUENT TAX LIABILITY OR A FELONY CONVICTION UNDER ANY FEDERAL LAW (FEB 2016)

(a) As required by sections 744 and 745 of Division E of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235), and similar provisions, if contained in subsequent appropriations acts, the Government will not enter into a contract with any corporation that--

(b) The Offeror represents that--

(1) It is [] is not [] a corporation that has any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability; and

(2) It is [] is not [] a corporation that was convicted of a felony criminal violation under a Federal law within the preceding 24 months.

52.212-4 CONTRACT TERMS AND CONDITIONS-- COMMERCIAL ITEMS (MAY 2015)

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to 41 U.S.C. chapter 71, Contract Disputes", as amended (41 U.S.C. 601-613). Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement or any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include--

(i) Name and address of the Contractor;

(ii) Invoice date and number;

(iii) Contract number, contract line item number and, if applicable, the order number;

(iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;

(v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;

(vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;

(viii) Name, title, and phone number of person to notify in event of defective invoice; and

(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer--Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.--

(1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) Prompt payment. The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) Electronic Funds Transfer (EFT). If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) Discount. In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) Overpayments. If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall--

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the--

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected contract line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) Interest.

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) Final decisions. The Contracting Officer will issue a final decision as required by 33.211 if--

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on--

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) Risk of loss. Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.

(l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) Compliance with laws unique to Government contracts. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) Order of precedence. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order: (1) the schedule of supplies/services; (2) The Assignments, Disputes, Payments, Invoice, Other

Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause; (3) the clause at 52.212-5; (4) addenda to this solicitation or contract, including any license agreements for computer software; (5) solicitation provisions if this is a solicitation; (6) other paragraphs of this clause; (7) the Standard Form 1449; (8) other documents, exhibits, and attachments; and (9) the specification.

(t) System for Award Management (SAM). (1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) Unauthorized Obligations.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (APR 2016)

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

Inverted domestic corporation means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except--

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

Sensitive technology--

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically--

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern--

(1) Means a small business concern--

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern" means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

(2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term "successor" does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern--

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and
