The following have been added by full text:

AMENDMENT 0001

1. Revisions to the evaluation factor are as follows (changes are in bold):

a) Section 00150 Notice to Offerors Part 1.6 paragraph 3 (b) Definition of a Relevant Project is revised to change the period for completed projects from five years to seven years. The revision is as follows:

Definition of a Relevant Project: A relevant project is defined as a project demonstrating multidiscipline vertical construction experience on projects with a contract value of one million dollars (\$1M) or greater. Projects shall be completed by the Offeror as the Prime Construction Contractor within the past **seven (7)** years of issuance of this RFP. Projects must be complete prior to the proposal due date. Projects submitted for consideration shall include at least one (1) new construction relevant project and one (1) renovation relevant project.

b) Section 00150 Notice to Offerors Part 1.6 paragraph 3(b)(1)(i) paragraph 7 is revised to correct a typo. The correct project submission limit is five. The revision is as follows:

If the Offeror is a Joint Venture (JV), relevant project experience should be submitted for projects completed by the Joint Venture entity. If the Joint Venture does not have shared experience, projects may be submitted for the Joint Venture members. Offerors who fail to submit experience for all Joint Venture members may be rated lower. Offerors are still limited to a total of **five (5)** projects combined.

2. An updated PPI Log (PPI Log as of 4-1-16) has been posted to NECO under additional documents.

All other terms and conditions remain unchanged.
